**Position Purpose:** The responsibility of the Journeyman Lineman is to construct and maintain the electrical distribution facilities.

#### **Reasonable Accommodations Statement**

#### **Core Functions Statement(s)**

- Perform a wide variety of manual duties associated with typical lineman work, both hot and cold, consisting of maintenance and repair of existing distribution lines and equipment, trouble shooting, diagnosis, disconnecting, disassembly, replacement of defective components, and rewiring and testing completed repairs to insure proper operation.
- Assist maintenance personnel with the repair and testing of reclosers, metering, capacitor banks and controls and other devices.
- Repair and replace fixtures, wiring and relays and replace bulbs on existing lighting circuits. Install services and meters and work cut-offs and retirements.
- Be available for standby as one of the emergency trouble crew members on a rotational basis.
- Be available for after-hours problem repairs, outages, and schedule work which would include working the fair share of all necessary overtime.
- Must be able to get along with fellow employees and interact with customers in such a manner as to build a positive image of JU.
- Train and instruct apprentice lineman in duties they are to perform.
- Perform work utilizing climbing tools and/or aerial lift trucks.
- Perform any other duties as assigned by the Foreman.

#### **Additional responsibilities**

- As part of a service oriented organization, perform any and all duties requested, whether scheduled or on an emergency basis.
- Observes and follows all safety rules, procedures, standards and specification codes in all job aspects.
- Ability to maintain reliable, predictable, and reasonable attendance.
- Must maintain a valid drivers' license from state of residence.

#### **Qualifications: Knowledge, Skills, & Abilities**

- Required High School Diploma or General Education Degree (GED).
- Minimum of 4 plus years of experience in the apprentice lineman position.
- Must have a CDL license.
- Completion of an approved Apprentice Lineman Program.
- Basic or limited computer skills: knows the fundamental concepts.
- Communicate frequently in a professional manner with internal and external persons
- Ability to perform work accurately and thoroughly.
- Ability to pay attention to the minute details of a project or task.
- Ability to comprehend complex technical topics and specialized information.

**Other requirements:**

- May be required to attend up to but not limited to 20 hours annually of certification training.
- Seek to stay abreast new technology to ensure best practices for operations.
